All the pesticides & rodenticides shall be certified for use by the competent authority. The record of medicines / drugs / pesticides etc used for this work along with its concentration / dilution rate & certified methodology must be submitted along with monthly bills.
- c) Staff should be adequately trained in house or by out side agency to carry out safe, effective and appropriate pest management / control measures specific to Food Industry or Dairy.
- d) The contractor will be solely responsible for the safety and security of the employee as per the Labour Laws and MRSDMM will not be liable for the any untoward incidence or legal bindings.
- A responsible person of the contractor shall visit in person to the Dept. Head of the MRSDMM / Dairy to record the effectiveness of the pest control & submit report to management along with the monthly bills. Also he shall attend all the audits.
- f) The record of medicines / drugs / pesticides etc used for this work along with its concentration / dilution rate & certified methodology must be submitted challen with gate entery along with monthly bills & also shall display at prominent places.
- 10) The Managing Director, MRSDMM does not bind himself to accept the lowest Contract and reserves the right to accept/reject any or all the Contractors received without assigning any reason whatsoever. GENERAL OBLIGATION

1) Interpretation of Contract Documents :

In the contract documents unless other wise stated specifically, the singular shall include the plural and vice versa wherever the context so required. The words and phrases used in these documents shall have the same meaning as is normally assigned to them. However, in case of dispute the decision of MRSDMM shall be final and binding on all parties.

- 2) All compensation or other sums of money payable by the contractor to the MRSDMM under terms of this contract may be deducted from his Security Deposit or any sums which may be due or may become due to the contractor by the MRSDMM without prejudice to the rights and privileges of the MRSDMM to have recourse to any other means of remedies.
- 3) The Contractor will have to execute an Agreement/ affidavit on stamp paper of requisite amount, cost of which should be borne by him, incorporating all these terms and conditions.
- 4) That the employees/ employed by the Contractor shall be the employees of the sole contractor only and the MRSDMM shall have no supervision or control over them.
- 5) The contractor shall scrupulously adhere and implement all labour laws applicable to him. The Contractor shall obtain a valid license under the Contract Labour Abolition Act and renew the same every year. The Contractor shall maintain Muster Roll-Cum-Wage Register and pay the minimum wages as per law and any revisions as notified by the State Government from time to time.
- 6) The contractor shall produce for inspection to the MRSDMM authorized officials, the above records as and when required.
- 7) The MRSDMM shall be entitled to deduct from the security deposit, Contractor's charges, any money that the MRSDMM may become liable to pay on account of any court cases filed by the employees of the Contractor or their Union against the MRSDMM including the legal expenses that the MRSDMM may have to incur on account of the above court cases. The Contractor shall indemnify and keep indemnified the MRSDMM for the above amounts.

- 9) The contractor shall make it clear to the employees employed by him that the said employees are not entitled and shall not claim any parity or wage scales or absorption with the employees of the MRSDMM.
- 10) MRSDMM reserves the right to terminate this agreement by giving one months' notice.
- 11) The contractor in general shall indemnify and keep indemnified the MRSDMM for any payment which the Contractor is required to make to any persons on account of the contractor.
- 12) In the event of breach of any of the terms and conditions contained in the tender as well as provisions of any law for the time being in force, the management is fully empowered to forfeit the amount of security deposit and terminate the contractor forthwith at his own risks and costs. The extra costs, for making alternative arrangements, shall be recoverable from the contractor.
- 13) The rate quoted shall remain constant and shall be applicable for One year.
- 14) The Contractor shall pay wages to the laboures / workers engaged according to the provisions of payment of Minimum Wages Act and so will be the minimum wages paid and all other facilities and amenities provided, such as bonus, ESIC, PF, Uniforms, Shoes, Public holidays, to and fro conveyance charges etc. as admissible under the provisions of Labour Act. It will be the sole responsibility of the contractor to pay such wages and provide amenities, facilities and benefits etc.
- 15) It is necessary to change the contract labours and appoint new labours after every six months.
- 16) All the disputes arising out of the contract shall be under the Mumbai Jurisdiction only.
